Report on Two days Training Programme on Preparation of Microplan under Ama Jangala Yojana for Forest Personnel and Team Members of Partner NGOs held at IMAGE, Bhubaneswar on 22nd and 23rd July 2016

Introduction:

AmaJangalaYojana (AJY) or Community Forest Protection and Management Programme (CFPMP) is a flagship programme of Government of Odisha being implemented by Odisha Forestry Sector Development Society (OFSDS) in JFM mode covering 7000 Vana Surakhya Samitis (VSSs) spread over 30 Forest and Wildlife Divisions.

The main objectives of AJY Scheme are:

1. To conserve and restore degraded forests through forest restoration initiatives.
2. To arrest further degradation of forests through participatory forest conservation and management strategy.
3. To empower forest dependent communities by building up their capacity to participate in the sustainable forest management.
4. To improve the livelihood opportunities of the forest dependent communities so as to reduce their dependence on forests.

Out of 7000 VSSs, 2000, 2500 and 2500 number of VSSs, respectively will be covered in the first three years of implementation of the scheme, i.e., during 2016-17, 2017-18 and 2018-19. The interventions of forest restocking in these VSSs/EDCs will be maintained for next three (i.e., in 2019- 20, 2020- 21 and 2021- 22) along with forest conservation, management and capacity building initiatives.

Capacity building of village community as well as the partner NGOs is an important component of the scheme which is proposed to be achieved by imparting on the job trainings on various site specific forestry, income generating and livelihood themes to the VSS/SHG members.

About the Training Programme:

A two day Training programme on Preparation of Micro plan under AmaJangalaYojana was conducted at IMAGE, Siripur, Bhubaneswar during 22nd and 23rd July 2016 with a well developed session plan (Annexure -I).

Objective of the training programme:

1. To make the participants well conversant with a MicroPlan document.
2. To train them on what are the different sources of collecting information.
3. What is PRA, its methods and how it helps for data collection and interpretation.
4. Different secondary sources of information.
5. What does Socio- Economic Profile of a village mean and how it is helpful for Micro Plan

6. The relevance of Livelihood Analysis for a VSS.
7. How to develop Forest Development Plan for a particular VSS.
8. Preparation of Capacity Building Plan for a VSS.
9. Methodology for Preparation of Village Perspective Plan and Annual Action Plan in context to preparation of Micro Plan for AJY.

Participants:

The Forest Personnel and Team Members of partner- NGOs from Malkanagiri and Kalahandi (North) Divisions attended the training Programme. There are 55 nos of participants from Kalahandi (N) Division and 26 nos participants from Malkangiri Division participated in the training programme.

Proceedings of the training programme:

Day 1:

On the first day of the training programme, Additional Project Director (AJY) Dr. Meeta Biswal, IFS inaugurated the event with warm welcome to all the participants. Sri P.C. Mishra, IFS, Joint Project Director (IME) also shared his valuable thoughts with the participants and the objective of conducting such training programmes. Dr Pradeep Raj Karat, IFS, Joint Project Director (A&F) also expressed his valuable ideas to the participants.

The inaugural session was followed by different technical sessions as planned in the session plan. The sessions were taken by APD-AJY, DPDs and Technical Experts of OFSDS. The teaching was conducted in participatory mode for more involvement of participants. The different sessions as planned were taken by the resource persons and the main objective of the second day programme was to give hands on training to the participants on sector wise planning for the Micro plan document for constructive implementation of the programme in convergence with other line



departments.

Representatives from both Forest and P-NGO personnel spoke their mind and informed that the training was really helpful for their understanding on preparation of a Micro Plan although they had prepared this kind of documents earlier with lesser knowledge.
