Inviting a reference to your Letter No.F.No.12-2-3/98-EAPdt.11.11.2016 on the subject noted above, I am directed to say that the Detailed Project Report (DPR) at a total cost of ₹1739.50 crore alongwith other enclosures were sent to your office (1.Approval of SLPMC, 2.Approval of the Planning Commission of India). The DEA included this "project" in the rolling plan and forwarded to JICA. JICA, on receipt of the Project Proposal with recommendation of DEA, commissioned the services of a Supplemental Survey Team for examination & rationalization of the project proposal. The JICA Fact Finding Mission visited Odisha from 07.11.2016 to 18.11.2016 & held discussion with OFSDS Officials. After detail discussion & deliberation the above Mission rationalized the project proposal at a total cost of ₹998.25 Cr. for implementation over a period of 10 years. The Detailed Project Report (DPR) has been rationalized accordingly. The Rationalized Detailed Project Report (RDPR) is attached herewith (3 Copies).

You are therefore requested to consider & send it to the Ministry Finance, Department of Economic Affairs to recommend the same to JICA in order to initiate the process of project appraisal by way of dispatching the Appraisal Mission for finalization of the project.
